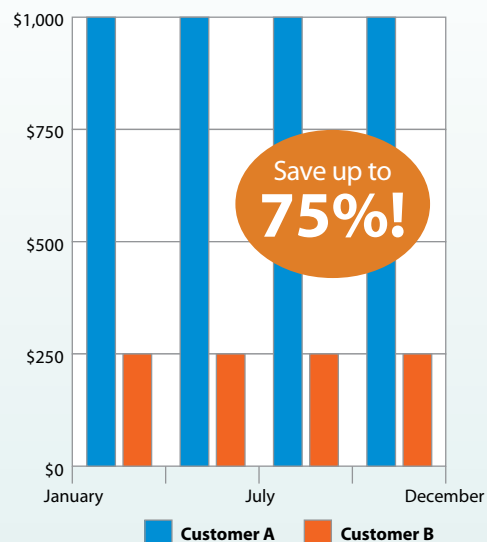
\$1,000 per order x 4 orders = **\$4,000 without standing order**
